

Name Your Runner Trackside Facebook Competition

Terms and Conditions

- The competition will open on Wednesday, 9 March 2016 at 9:00am (AEDT) and will close on Tuesday, 15 March 2016 at 9:00am (AEDT) (**Promotion Period**).
- The promotion is open to Australian residents in NSW, VIC and ACT only. You must be 18 years old or over to enter.
- At the start of the Promotion Period, the Promoter will post a Facebook competition on the TAB Trackside page (**Competition Post**).
- To enter, eligible entrants must during the Promotion Period:
 - (a) 'Like' Trackside on Facebook; and
 - (b) Submit a unique name for a Trackside runner made up of their favourite fruit or vegetable and the surname of their favourite NRL player in 16 characters or less (e.g. Banana Burgess / Apple Radradra) by commenting under the Competition Post (**Entry**).
- Multiple Entries are permitted per person. However, a person is only eligible to win one Prize.
- At 12:00pm on Wednesday, 16 March 2016, the Promoter will select (at its sole discretion) the 12 best and most creative Entries from all of the valid Entries received during the Promotion Period and each person whose Entry is selected will be a Winner (each a **Winner**).
- The Promoter reserves the right to disqualify or delete from the Competition Post any entry that the Promoter considers is offensive, indecent, obscene, defamatory, racist, not in good taste, in breach of any law or regulation or in breach of any intellectual property rights of a third party (including trademarks/copyright infringement). This is at the Promoter's absolute discretion and discussions will not be entered into.
- Each Winner will have their Trackside runner name displayed on a Trackside race in participating Victorian, NSW and ACT venues on a day after the Promotion Period as advised by the Promoter and win a NRL jersey for the team of their choice valid at \$179.99 (**Prize**). There are a total of 12 Prizes, one for each of the 12 Winners.
- Winners will be notified via Facebook. Winners will also be sent a direct message by a Tabcorp representative via Facebook and must accept the prize and provide the Promoter with any required details to enable the Promoter to verify the Winner's age and residency and to arrange delivery of the Prize.
- The Promoter will advise the Winner of when their Trackside runner name will be displayed on a Trackside race and post the NRL jersey component of the Prize to the Winner within 28 days after a Winner is contacted.
